#### DISTRIBUTION REPORT.

Meeting on the 16<sup>th</sup>. April 2007 regarding discussions on new leaflet. Final draft available to consider. Steve Barnes has obtained several quotes with relevant qualities. Group agreed to release funds for 5,000 & £190.00 + £10.00.

#### LEGAL & RESEARCH TEAM REPORT.

Welcome to new members.

No guest speaker but a question and answer session by Shlomo.

Costing the Earth programme on Radio 4. War on Waste.

24/05/07 9-9.30 am and 25/05/07 11-11.30

Professor Swithenbank rejected as an 'independent advisor' due to his involvement with Veolia. N&SDC have now asked Shlomo for any other names.

Paddy Tipping and 3 senior officers from NCC met on the 4<sup>th</sup>. May.

Any discussions at present between the L&RT and Veolia are going through the planning department at NCC.

Meeting to be organised at a later date with the Environment Agency. If the EA disagree with proposals they could stop development or impose many conditions etc.

NCC and PFI contract. Shlomo has requested a draft of the contract between Veolia and NCC re waste management strategies. Hopefully, in the next 3-4 weeks, depending on their legal team.

Discussion on the delay of timescale for the release of documents in accordance with the freedom of information act and NCC own guidelines ( within 31days). Shlomo read out various options we could proceed with, re complaint on non-disclosure of the PFI document. See Shlomo report.

Q & A session by Shlomo.

Site meeting between Veolia, UK Coal, District Councillors. No one invited from PAIN took place at Pit Lane. Linda has map which she

will try to copy for next meeting and details of the proposals from UK coal. Heath? Desert?  
Planning process explained further.  
Environmental Impact Assessment explained by Shlomo.

Bernard Thompson, Chairman, suggested that each group nominate a member to feed back to the other teams, possibly group leaders, in order to keep the communication flowing ie. Ideas for leaflet, content etc.

Q. If Rainworth defeats Veolia would the incinerator be sited elsewhere in Nottinghamshire?

A. Shlomo gave reasons on what grounds Veolia would drop application. With regard to the Freedom of Information, did we apply as the PAIN group? Or could individuals apply? Re PFI contract? Shlomo answered all questions fully.

Q. Has anyone contacted schools and local businesses?

A. Linda Tift, works with local schools but explained that this issue is considered political and schools have to remain apolitical, which is in essence that they do not become involved and remain neutral. However, for us, and many others this is an environmental issue and we are in fact fighting these proposals for the children in the area. Georgia Jones, aged 8, a pupil at Lake View School has written an article which can be read on the PAIN website.  
Very few businesses in Rainworth but certainly a point to consider. Melanie Patel was not at meeting but had previously voiced her intention to contact Center Parcs.
